PCSO Charlotte Carter gave an overview of the Community Speed Watch Scheme and shared some information on a local scheme in Cilcennin which is successful. Councillors raised their concerns again about speeding through Bentre'r Bryn, Cross Inn and Maenygroes. In order to proceed Charlotte Carter will contact Ian from Go Safe and book an appointment for him to come out and complete a risk assessment on the above location to see if they are eligible. Criteria; 100m line of sight each way at each location.

In order for the scheme to be successful we would need ideally 8 volunteers who would need to be vetted. If the scheme were to go ahead, 3 volunteers would need to be 'on duty' every time.
