Cytunodd y cynghorwyr ar y pris hwn.	47	Correspondence 47.01 Meeting between representatives of the County Council and Town and Community Councils – November 2025 The Mid-County meeting is on Thursday, 27th November in Penmorfa. The following topics were discussed that the Councillors wish to ask about: - Reorganisation of Town and Community Councils in 2027 - Tourism Tax - Maintenance of Public Footpaths - Lack of involvement with community councils on local matters. It was agreed that Councillor Iau will write questions on behalf of the Community Council to be sent in advance before the meeting. 47.02 On-Street EV Charging Infrastructure – Ceredigion Council Cllr Vaux and the Clerk have received correspondence from an officer within the Council with proposals to locate 2 EV charging points within a layby in Cross Inn. Cllr Vaux has expressed his concerns at the loss of parking at this location following concerns from residents. It was agreed to invite the officer to attend a Council meeting to give Councillors further information on the project. Clerk to contact the Officer. 47.03 Bro Hafan Play Area The land for the play area is required to be re-registered with HM Land Registry in the Community Council's name. The clerk has contacted a local solicitor for support, the rough cost of this would be £250 +VAT. It was agreed to proceed with this under the above price. Clerk to also discuss with the solicitor the merger of Llanllwchaearn Community Council with New Quay Town Council in May 2027, would this effect the process as it is now. Cllr Vaux has had a price to cut the brambles at the back of the play area as they are growing through the fence and also to cut the tree which is overhanging the play area. Price was £250.00. Councillors agreed to this price. Cllr Vaux to

Mae'r cysgodfannau bysiau hyn ar yr ochr chwith y prif ffordd os ydych yn teithio o Synod Inn i Gei Newydd ac maen nhw wedi ei hadeiladu allan o frics. Bydd y Clerc yn anfon y lleoliadau i'r swyddog gan ddefnyddio 'what3words.' Hefyd, roedd y Cynghorwyr eisiau nodi bod sawl cysgodfan bysiau wedi'u cynnwys yn y ddogfen fel pe baent mewn lleoliad penodol ond nad ydynt yn bodoli.

Discussions were held about the green of which the County Council are responsible for but due to financial restraints aren't able to cut very often. Cllr Vaux will ask the contractor of work above for a price to cut and maintain this for the year 2026/27.

47.04 Bus Shelters

The Clerk has received an email from an officer at Ceredigion County Council stating that they are contacting Town and Community Councils to confirm the ownership of bus shelters in their area. Discussions were held on the Excel spreadsheet which was received with the letter. The clerk had checked the Community Council's asset register which stated that there were 2 under the Community Council's ownership – one in Pentre'r Bryn and one in Cross Inn. These bus shelters are on the left hand side if travelling from Synod Inn down towards New Quay and they are both built using bricks. Clerk will send the exact locations to the officer using 'what3words.' Councillors also wished to note that there are several bus shelters included in the document stated as at a location but do not exist.
