54.01 Road Closure – Welsh Water work

Codwyd pryderon gan Gynghorwyr am effaith y cau ffyrdd diweddar fyddai'n ei chael ar y busnesau yn Cross Inn. Esboniodd Cyngh. Vaux ei fod yn ymwybodol o ychydig o fusnesau sydd wedi cysylltu â Dŵr Cymru i dderbyn taliad am yr effaith mae cau'r ffordd yn ei chael ar eu busnes. Fel arfer, mae Cyngh. Vaux yn derbyn diweddariad ar ddechrau pob mis gan Dŵr Cymru, ond mae'n credu y dylai'r gwaith gael ei gwblhau erbyn y Pasg.

Concerns were raised by Councillors on the effect that the recent road closures will have on the businesses in Cross Inn. Cllr Vaux explained that he was aware of a few business that have been in contact with Welsh Water to receive a payment for the impact the road closure is having on their business. Cllr Vaux usually receives an update at the start of every month from Welsh Water, but he believes the work should be completed by Easter.

Cllr Ioan explained that he felt the Community Council should be supporting the local hall as does one of the neighbouring Community Councils.

The clerk explained to Councillors that as a decision has already been made / set on the budget back in December 2025, this can't be looked at again for another 6 months, the clerk also explained that the allocation of S133 was not included in the budget report. The clerk will contact the local One Voice Wales officer for advice regarding this matter.

The process will move to the survey stage first, followed by the preparation of drawings, before any ground works commence. Please note that this EV charging infrastructure across Ceredigion is intended for residential on-street charging for longer periods. It is not designed for business use, in line with the grant conditions. Following discussions during the Council meeting it was agreed to contact the officer to inform him the Community Council did not agree with the proposal of putting EV charges at the location identified for the following reasons; • Loss of parking for residents • Loss of Post Officer provision which is a vital service for Cross Inn • Loss of Natwest bank provision which is a vital service for Cross Inn.
